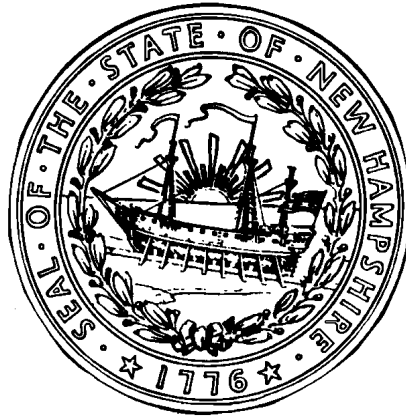

Ilmooga way badanaaba in badantaa inii ki guuloysidaan haddii waalidiinta ii ma'alimiinta wada shaqeeyaan si lin hormariyo o lin deero hadafka walbarasho ee ilmooshoo itaalka dorayaan. Shar'iga Gobolka ii kan Federaalka way waalidiinta siyaayana fursado oo waalidiinta kaalin inka qaadadayaan qorsheynta ii go'aan deerista la hiriirto baahida ilmooshoo walbarashidiyoo gaarka ah.

Buug-yaraagaan way lin soo saareey inii waalidinta, ardayda wi wiin oo itaalka doron, ma'alimiinta ii kuwa kaleba siiyo ma'luumaad ki saabsan huquuqda hanaanka walbarashada gaarka ee waalidka/unnuga. Huquuqdaan way la dhaheeyee "Nidaamka Badbaadida." Waalidiinta way waa hubin gaar ee Koohda IEP. Koohda IEP way waa kooh badanaba ku kooban kuwa go'aanka in deeraaw ilmooga qabaan walbarashada ii adeega gaarka eh. Waalidiinta way ayaana dad hubno buuto ku eyaan Koohda IEP.

Koohda IEP go'aan adag ku gaarayana qiimeenta, haq in weelashada, Barnaamijka Walbarashada Qof Ahaaneed (IEP), ii meeleeenta walbarashada ilmoogaa. Magaaga rasmiga ee Koohda way waa Koohda IEP, laakiin way kaloo suurtoagal eh in liin ki weero maga'yaal kaleet oo way ki hirintaa howla ama walyaalooga qobodayaan ee liinka jiwaabaw. Adi way etaa hubin muhiim eh oo ki tirsin Koohda IEP; edkaa way in baahinyaa ini liki daro. Qaabka walbarashada gaarka way waalidiinta siyeyee fursad i aqoontiyoo i qibrada ilmooshoo kila wadaagan dadka kale ee Koohda ku mid eh. Shar'iga way liin aasaaseey inii waalidiinta ku qeeb qaadidaayan siiyo fursad qaabka walbarashada gaarka ii in la hormariyo wadhadalka in dhahooyo iskoolaadka ii waalidiinta iyaga oo ki hadalaayaan magaaga ilmooshoo. Qaabka walbarashada gaarka way eed in taaba-galeyee marka waalidiinta ii shaqaalooga iskoolka in si fayle liin wargeliyo oona awoodaan inii wada shaqeeyaan.

Way sidoo kaleet muhiim in ataa inii waalidiinta ii dadka kaleet oo lugta ki leyaan qaabka walbarashada gaarka eh in oo kasaan huquuqdiyoo oo ku warhaayaan koobnaanta waqtiga haqa ii hadeysnaanta kaleet in si buuto liin halo walbarasho haboon oo bilaash eh oo sha'abka biyaayaan (FAPE).

Heerka Shaqsiyaadka Itaal doron (IDEA 2004) way iskoolyaalka degmada inka baahinyaa in waalidiinta siyaan koobbi ku mid eh nidaamka Badbaadida (huquuqda waalidka) hal mar inta iskoolka furunyo. Way jiree waqtiyaal kale oo dheeraad eh mar adi koobbi li ki siiyo ato: (1) marka inka horeyto ee likiin soo gudbiyo ama waalidka qiimeen soo odsido; (2) Marka inka horeyto ee la halo ashtakada Gobolka ama ashtakada hab-soodka shar'iga ee koowaad ee sanad dugsiyeedka; marka go'aan luku deero in tillaabo edbin la qaado taasoo sheeni korto isbadel Meeleen; ii (4) odsiga waalidka.

Fadlan ogaaw in kastoo buug-yaraagan buuyow shar'iga hoos koyaw > *Heerka Shaqsiyaadka Itaal doryaan ee 2004* (IDEA 2004) oo inii waalidiinta la siyaw dokumenti qoraal eh oo sharaxaw Nidaamka Badbaadida ee i haqa in leyaan, ma ki jirto qoraalka oo dhan ee Federaalka ama shar'yada ii heerarka Walbarashada gaarka eh ee Gobolka.

Husuusin: Haanoo ku mid eh kulumeedan li soo koobi kore.

Hanaanka walbarashada gaarka way wehliyee muraaja'o sanadleega IEP ii meeleynta, taasoo ki saleysanyo Ma'luumaad sida qiimeen rasmi eh ii mid rasmi in haayne, indho indheen ii horumarka li ki suubiyi yoolka ii hadafdheeda IEP woqtiga li roogo.

Agoonsiga/Halowka Ilmooga Qof welba canugii iyii ku shakiyaan in usi/iyi qabto itaaldaro ama qabo baahi walbarasho gaar eh in soo diri koraan. Way intaas dheeraa, iskoolada degmada oo dhan ee isti'malayaan qaabka walbarashada gaarka eh, way waa ini halaan, eddeeyaan, oo iyi qiimooyaan dhamaan ilmooga liinku shakiyo itaaldaro da'diyoona ato 2.5 sano jir ama ku wiin laakiin ku yar 21 sano jir si liin hubiyo in ilmoogaas li hali, li eddaayi, oo iyi halaan adeegga in baahiyiin.

Ki Wareejin ii Go'aan ki Wareejin Maddii adi, ma'alini ama lang kaleet ku shakiyo in ilmo qabaan itaaldornaan oo in baahinyo walbarasho gaar eh, iskoolka degmada way luku fadeeye in soo wareejhiyo. Hoo wareejinta ku kooyto qof adi inka ahaayne, oo nagada koro ma'alinka ilmooga, isla markiiba qoraal ahaan ayaa liki soo wargeliyee, in wareejin la suubiyi. Kulun go'aan wareejin, kasoo adina liki marti qaadi doono, waa in 15 gee' gudaashoo li qobodaa laku bilaabo maddii gudbinta li hali. Kulunkun (dhamaan kulumeeda Koohda IEP haatow) way waa in la qobodaa waqti, saa'ad, ii meel adi ii iskoolkaba ke heliyi kortaan. Koohda IEP way suurtoagal etaa in iyo go'aamiyaan inin jirne wal tilmaamow in unugaa in qabne itaaldoro oo anin baahinaayne baahi walbarasho gaar eh ama baahi gaar eh ii adeegyo la hiriiryo oo waqtigaan iskoolka unugaa iskoolka si kaleet oo aadiga eh sida adeegga walbarasho ee aadiga ki kaalmooyo koro. Hoo kaleet, way go'aamiyayana ini jerto sabab kaleet oo liinku shakiyo ini unnuga suurtoagal eto in usi qobo itaaldornaan oo in baahinyo ini li qiimooyo.

Iskoolka way waa ini ki siyaa digniin qoraal ee go'aankii Koohda IEP. Ogeysiiskan way waa "Ogeysiiska Qoraalka Hore" ee ki sharahan bogga 6 ee buug yaragan. Haddii Koohda IEP go'aamiso in imtixaan dheeraad muhiim liin baahinyo, maddaas sidoo kaleet ogeysiiska qoraalka hore way la so'ode doonee ogolaansho waalidiinta si qiimeen shaqsi kasta ee liin baahinyo liin suubiyi fadii si liin ogaado haddii unugaa qabo itaaldaro aafimaad.

Qiimeen Maddii ilmoogaa la fadaaw in liin tehgiliyo walbarasho gaar eh, ogolaanshagaa oo qoraal eh iye li fadee kohor inti liin qiimooyne. Iskoolka degmadaa iye qobodee qiimeenta, adda wal qarash kiinka bahaaw ma jiro, lan in tababaran oo shahaado ama batanti qiimeeye haysido imtixaan ku qaado. Kudambe maddii iskoolka degmada halaan ogolaanshigaa oo qoraal oo qiimeenta eh, qiimeenta inki horreyto way waa in laka dhamaayaa 60 beri gudaashoo. Dib in qiimeeyowka, hoola qiimeeyowka may waa inii liki dhammaayo 60 beri gudaashoo oggolaanshaga waalidka kudembe ama gebogebada dheereeyowka oo inki badanayne 30 beri.

LEA may waalidiinta siiyi doonanaa nuqul ku mid eh qiimeenta imtihaanka lankii biyi ii warbihin linku fiirsidaw 5 maalin ka hor inta shirka Koohda IEP al qobone oo qiimeenta ii warbihinta laku fiirsadow iye luku doodee. LEA may biyi doonanaa warbihintii uyu oo in diraayaa waalidiinti too boostada Mareykanka ilaa waalidiinta ii LEA ki heliyyaan inii qaab kale ku diraan. Hoo adi inka qanacsinaayne qiimeenta iskoolka degmada qobodeen, way iskoolka degmada ku odsidi kortee in ki siyaan qiimeen walbarasho oo madi banaan kasoo adi qarash inkin ki fidhine.

Hooba qiimeenta li dhamaayo, may laku siiyeyee qoraal koobon.

Qeebta Go'aan ku deerista Haq in ahaadowka ii Itaaldoroda Maddii qiimeenta li dhamaayo, Koohda IEP way isticmaalasee Ma'luumaadkaas si in ogaato haddii unugaa haq in leyo in halo walbarasho gaar eh ii in kale. Si haq liinka halo, unugaa way waa in qabaa itaaldoro oona in baahinyaa walbarasho gaar eh ama walbarasho gaar eh ii adeegyo la hiriiro manfacu walbarasho. Maddaas unugaa way liin tehgeliyeyee hal ama mid ku mid eh nuu'yada itaaldoro gaar eh oo ki qoronto Heerka NH 1102.01(t). IEP may waa inii kulumaan sediidii sanaba hal mar si go'aan unku deeraan haq in weeladowka walbarashada gaarka eh.

IEP Soo Saarowshe 30 maalmood gudaashoo walaagii ku dambooyo kudib maddii la ogaado in unugaa haq in leyo walbarashada gaar eh, Koohda IEP kulumaayan si unugaa liinka qorsheeyo Barnaamij Shakhsiyadeed ee Walbarasho oo lin kasaw (Individualized education program) (IEP). IEP-ga li soo gaabiyo ma taaba galow ilaa ii intii adi ka ogolaato oo adi sahihto. Koohda IEP way la socotee qeeb gaar eh oo liska rabo ee ke qoran Heerka NH Ed 1109.01 ii 1109.03.

Mar haddii unugaa haysado IEP, muraajico/dib in fiiriyaayanaa kulunka Kooxda IEP sanadkii hal nibir. Unugaa way waa in ki weelo meelii IEP ki heliyeen maddii sanad iskooleedka bilaabidaw. Ogeysiis qoron oo Kooxda IEP kulanshoo eh in luku siiyo wu inki yaraan 10 maalmood kohor intii kulunka li qobone. Ogeysiiska inii ki jiro wu waqtiga ii meela kulunka ku ki dhiyaw, muraadka, ii liiska dadka kooyaayaan. Ikhtiyaarka waalidka ama hay'ada, shaqsiyaadka kale oo ilmi in le ama waayo-arag gooni eh oo li hiriirto unnuga, oo iniski jiraan adeega li hiriirto shaqaalaga si ki habboon ii [marwelba oo habboonta](#), unnuga itaalka doron liki asuumi kore. lidoo lin baahanaane, may hushmad in ettaa waalidka inii luku wargeliyo iskoolka muddo hore hook i asumaana lang dheeri, ama dad kooyaw kulunka.

Go'aaminta Meeleenta Walbarasho Ka dambe maddii IEP la soo saaro, Kooxda IEP kulumaan si liin go'aamiyo meeleenta meela inka caaqibada yar (LRE) meelaaso unugaaga ku halow walbarasho gaar eh ii adeegyo la hiriira sida ki qeehan IEP sheey/she.

Hirgelinta ii Dabagalka Waalidiinta, muta'alimiinta ii dadka kaleet ee kaalinta ki leyaan in la so'odaan unugaaga horumarshey ee markasta ii in hubiyaan baahida walbarashada unugaaga in la haqab tiri. Haddii soo baho wel-wel ki saabsan walbarashada unugaa, way suurto gal eh in kulun Kooxda IEP lo odsodo oo balan daahitaan in la haayne lo qobodo.

Oggolaansho Waalid

Heerarka New Hampshire ee Walbarashada Ilmooga Itaal doroda Qabaan ~ Ed 1120.04

Iskool dheeda degmada way waa in odsidaan oggolaanshaha waalidiinta, qoraal ahaa, walaagi walbarasho gaar eh ii adeegihii la hiriira ee la siyaw cunug itaal doron, ii sidoo kale howlaha kale kasoo qeeb ku ayo hanaanka walbarashada gaarka, in ku ahaayne marhaladdo gaar eh.

Ogolaanshaha may liki jeedee:

- (a) Si buuto may likinki sheegey dhammaan ma'luumaadka li hiriirro hoola I qabadaw oo oggolaansho luku afkii aadaa amase nooc kale oo liki hariirod;
- (b) Kasti oo ki rati, Iyigoo qoraal eh, howlooga liska rahi in la qobodayaan kasoo oggolaanshahaaga liiki baahidi, ii oggolaanshaha liki sheegi howlaha ii diiwan gelinta (hoo jiro) oo qoron oo lugudbiyaw ii qofka liin gudbiyaw; ii
- (c) (1) Kasti in siismada oggolaanshaha ato ikhtiyaari oo adi kula nagada korto waqtigii adi fadaaso; (2) Wal isku bedelkaa oggolaansha ficilkii horey in dhiyi wal muku bedlaaso ka dib markii adi oggolaansho adi siiso ii ka hor intii adi anis bedelne .

Way haysatee 14 maalmood luku soo billaabo taariikda odsigii iskoolka degmada oo qoraalka linki jiwaabaayi. Way haysitee 14 maalimood luku bilaabo taariiktata odsiga iskoolka degmada in qoraal ahaan inka soo juwaabo waqti dheeri ah.

Oggolaanshaha waalidka way waa in qoraal ahaataa oo waana ahaataa mid la "wargeliyi" taasi ato, way waa in adi kastaa walaaga la soo jeediyi, walaagii dhiyi koro (faa'ido ii khasaaroba) ficilka iskoolka soo jeediyoooyo, ii walaagii Kooxda IEP soo jeediyooyto kasoo oggolaansha isbadelka liki warsidooyo.

Iskooldheeda degmada way waa in halaan oggolaanshahaaga, qoraal kasoo ayo ka hor inta adi in ogolaane:

- Qiimeenta inka horooyto marka la suubiyaaw;
- Qodobka inka horooyo ee walbarashada gaarka eh ii adeegyada la hiriiro ee la siyaw unnuga itaalka doron;
- In sanad kasta la cusbooneysiyo IEP ga ii Meeleenta unnuga itaalka doron;
- Go'aan ka gaarista ama bedelka luku subiyaw shal soo'ida itaal doroda;
- Bedelka qaabka ama waqti laka daraw walbarashada gaarka ama walbarashada gaarka ii adeegyada la hiriiro;
- Qiimeen dib liin suubiyaaw;
- Eymis sha'ab la halo koro 34 CFR 300.154(d); ii
- Mar kasta oo iskoolka degmada soo jeediyo sidii liin hali fadii ceymis gooni liin leyo.

Sidoo kale ogolaansho ayaa liinka baahinya:

- Woqti liki daro si dib li in qiimeeyo. Iidoo jiro oggolaansho qoraal oo lamada dhini eh, waqtiga 60 maalmood hadidan iye lin baahanya Ed 1107.01(d) li dheerooyo kore oo tiro maalmayaal iye luku dhigi koro mana luku siyaadin koro 30 maalmood.
- Udurdaar hubnaha Koohda IEP marhaladooga qaarsho (Ed 1103.01(e)).

Husuusin: Ogolaansho qiimeenta hore maliin qaabooyo koro ogolaansho hore ee walbarashada gaarka eh ii adeega li hiriir.

Iskooldheeda degmada ma liinku baahinyo inii ogolaanshaga haaysidaan kuhor:

- Inta ii fiiriyayaan ma'luumaadka horey in haaysiideen oo qeeb ku ato qiimeenta unnuga ama dib in qiimeenta; ama
- Marka imitixaan fiiriyayaan ama qiimeen kale oo ilmooga dhan li siiyi, inku ahaayne ogolaansho waalidiinta ilmooshoo dhon in fadaayaan.

Marhaladooga Gaarka eh: Hoo iskoolka degmada in halno ogolaanshaha oo qoraal eyo 14 maalmood gudushee oo muujiyi korto in iskoolka qaadeen tillaabo suurto gal eh oo i ki abiraayeen in ogolaansho ki halaan, iskoolka degmada howl geliyi kore walyaalooga soo so'odo:

- In sanad kasta la cusbooneysiyo IEP ga ii Meeleenta unnuga itaalka doron;
- Go'aan ka gaarista ama bedelka luku subiyaw shal soo'ida itaal doroda;
- Bedelka qaabka ama waqti laka daraw walbarashada gaarka ama walbarashada gaarka ii adeegyada la hiriir;
- Qiimeen dib liin suubiyaw.

"Tillaabo suurto gal eh" way ku mid ataa in talefoon liin diri oo liiska deyi ii natiijida ku soo bati talefoonkaas la weeri, warqaddheeda likin soo diri oo (boosto li shahaadooyi ato, in la hali rasiidshe) ii jawaab kasta oo luku haayo, ii/ama diiwangelin kasta oo faahfaafsin sida booqosho reerka liki seedi ama goobta shaqada ii natiijida ku soo bati booqoshooyinkaan.

Ilmooga ki jiraan xanaanada DCYF huquuq waalideedka li roojihiyi, gobolka may soo maga'aabi koree meel gooni oo walbarasho.

Markii adiga ki fikiraaso ogolaansho, way muhiim ataa in adi weydiiso su'aalo ki saabsan wal kast a oo adi likiin warsidooyo in adi sahihto.

Way muhiim ataa in adi soo **noqdo** foormka ogolaanshaga **iskuulka degmada in soo nagto 14 maalin gudaashoo, ama waqtiga leki heshiyyi**. Woqtiga balanta way bilaabidase tariikhda iskoolka degmada kiin soo **diri** foormka ogolaansha. Fadlan tehgeli haddii foormka ogolaansha boostada kiin ki kooyo, way suurto gal atee in 14 maalin mar hore la dhaafi waqtiga adi hali odsashada ogolaanshaha. **Adi iye mas'uuliyad koo saarinta inii ka soo jawaabto.**

Way jiree afar siyaabood ee adi inka soo jawaabo korte odsiga ogolaanshahaaga. Adi **jawaabta** su'aal kasta in dooro korto way waa:

1. Hoo ogolaansho siido, isbedelka la soo jeediyi iye dhiyi doono.
2. Hoo ogolaansho diido, iskoolka degmada **ma** hergeliyo koro isbedelka la soo jeediyi. Iskoolka degmada way haasidee fursado oo iska deyaan in ogolaansho in halo:
 - a. Way suurto gal ataa in iskoolka degmada qobodo shir kale ee Koohda IEP oo wel welkaa luku hadalaaw;
 - b. Way suurto gal ataa in iskoolka degmada ka warsido in si ikhtiyaar eh in ku qeeb qaadato hanaanka Halin Dooda ee Kale, sida dhehdhehaadin ama shir dhehdhehaadi si heshiis liin deerii fadi.
 - c. Iskoolka degmada way liinku baahinyaa in soo jeediyi odis gaar eh qaab dhugunsi nidaam jiro.

Iskoolka degmada way suurto gal ataa in isticmaalne qaabka diidmida ogolaanshihiisa haddii adi diido in adi sahihto ama ka guul dareysato in ka sa jawaabto:

- si adi in odsato in halo walbarasho gaar eh ii adeegyo la hiriir markii inka horeytoba;
- haddii unugaag kiin seedooyo iskool gooni ah oo adi qarash shey diibidooyto;
- haddii adi reerka wal inka dhigooyto (walbarashada reerka) sida waafaqsan RSA 193-A. Ardayda-guriga walk u baradeen oo itaaldoron si kastaba haatow, mal ku eliyaaw inii halaan walbarasahda dad wiinaga ee bilaashka eh oo ki habboon oo dadka itaaldoron siyeen ardayda iskuulka ee itlldoron.

WPN way waa in qoraal ahataa oo luqad shacabka oo dhan isla kasaw ki qoronataa; tasoo ato, mid si sahlan liin kas koro. WPN way waa in afka qofka in dhaladi liinka sheegaa ama siyaabo qofka kasi koro liinka sheegaa (sida afka dhegooliyaalka) haddii waalidka isticmaalaw (inku ahaayne haddii taasi in suurto galaayne in la suubiyo).

Haddii adi dalbadooyto hab-so'odka dhugunsashada dacwad si adi in halo fadii qarashkii kiin ku baho way waa in ad feel garooyta odsigaas mudo 90 maalmood gudaashoo.

Muddada ii Dhugunsiyaalka ii Dib-in-fiiiriga Fudud Waahda Walbarashada ee Gobolka NH way waa in hubiyaa in ku yaraayne 45 maalin ka dib markii dhiyo 30 maalin muddada shirka halinta **ama** oo ki qeehan oo cinwaan hooseedka **iska hagaajinta ilaa ii 30 maalin ee muddada halinta**, inku yaraayne 45 maalin ka dib muddadi dib liin qobodi dhiiso:

- go'aan kama dambooska la ka deero dhugunsiga; **ii**
- koobbi eh go'aanka boosto liinka diro lamada koohba.

Sarkaalka dhugunsiga way suurto gal ataa in waqti gaar eh ki daro oo ku badan 45 maalin ee muddadii liinka tala gali ee lamada kooh dalbati.

Waalid kaas oo ayo koohda gacan- sareyto (halaan amar la jeelyo, ama mararka qaarkood, amar kaa soo ayo ugu horeynta ahaayii mid la jeelyo) marka dhugunsiga nidaamka jira ama mahkamada raf'aanka ee go'aanka Sarkaalka Dhugunsiga, way suurto gal ataa in haq in leyo in la soo nago qarashka abukaatiga ee aqli gal eh. Sida luku soo higidaw RSA 186 – C:16-b, (V) waalidka way waa in feelgareeya dalab oo ki dalbadaw qarashka abukaatiga mahkamada gobolka ama mahkamada federaalka inta liki jiro 120 maallin gudushoo markii la halo go'aanka Sarkaalka Dhugunsiga dacwada.

Ku saarowka in Dhigama koro Bedel Meeleen Ardayga in luku saaro asigoo aassaas liinku weelaw arrin edebta la hiriirto, ***haddii***

- Ku saarowka maywaa in ku badan 10 maalin iskool oo iska highto ama
- May jiree tahanayaal ka saarow oo koobaaw habka mayweeley kasaarowka iski darshoo maywaa 10 maalmo iskool wal ku badan, mayweeley akhlaakhda unuga si walk u ool eh iye la mid etta akhlaakhdiid dha'dooyinkii hore oo sababti inii sheento kasaarow faro badan; oo mayweeley sababyaalkan siyaadada eh ii sii dheeraanta ka saarowka, tirada woqtiga iski darshoo unuga luku saari, ki dhawaanshaha mid-mid luku saari.

Tani markii dhiiso, way waa in adi halaa koobbi ayo ogeysiiska dhooritaanka nidaamka. Shirka koohda IEP ka dib way waa in lo qobodaa, tomon maalin gudushoo markaa go'aanka la deero, in unugaa luku biyo walaagi laka wedo meelen bedel, ii Koohda IEP way waa in go'aamisaa ***haddii*** edebta ahaaytii 'calaamo' ee itaal doroda unugaa. Go'aan calaamo way waa go'aanka Koohda IEP in unugaa edebtiis ato ama in ahaayne itaal dorodiisa/diyee la hiriirto. Sida tan liin suubiyo, Koohda IEP way waa in fiiriyaan laba sheey oo suurto gal eh:

1. Akhlaaqda (edebta) "way sabab in ahaayteey, ama si toos ama hiriir ayaa la lahaaytii unugaa itaal dorodiis" ama
2. Akhlaaqda (edebta) oo liis warsidooyo "way ahaayteey walaagi si tooska ee sheeni in iskoolka degmada ki guul darooyisido in hirgeliyo IEP."

Haddii Koohda IEP go'aan ku deero in edebta ***ahaaytii*** calaamadooga itaal doroda unugaa, ***markaas*** Koohda IEP way waa in suubisaa mid ku mid eh walyaalooga soo so'odo:

- in midshoo lu suubiyo qiimeen dhaqan oo shaqaynaysa (FBA) inku ahaayne iskoolka degmada mar hore suubiyo FBA oo in diyaariyi qorshe dhegal dhaqan; ama

Go'aan Calaamo Markii unugaa iskoolka luku soo roojihiyo taas way waa isbedel ki kooyi Meeleenta, mar ala markii go'aanka la deero in tilaabo la qaado, way waa in liki soo wargeliyaa oo liki siyaa ogeysiis dhooritaan nidaam. Islamarkii, lakiin inku yaraayne 10 maalin ee maalmooqa iskoolka go'aanka markii la deero ku bacdi, Koohda IEP ii shaqaalooga hirfadda in leyaan ee kale, sida dhakhtarka cilmi-nafsiga iskoolka, way waa in shir goboda, si go'aan muuqdo liinku suubiyo.

Haddii qof hore insuubiyi, sidoo kale FBA way qobotey oo dejiseey qorsho dhahgal dhaqan. Tan way laka qobode koree isla shirkaas kii go'aan muuqda la suubiyaa.

Kubiyow Lu Ku Biyaw Meel Bedel Walbarashom Kumeelgaadha (IAES) "haaladooga gaar," hoos kooyto (husuuso in IDEA 2004 in ogolaadaaso "keesba-kees" in qobodaas arrimooga aqlaaqda ki saabsan), shaqaalaha iskoolka ardayga ku saar koro IAES in inku badanaayne 45 maalin iskoolka "ayidii al fiiriyaayne in akhlaaqda ahaaytii walaagii inka wacanaayi itaal doroda unnuga, haddii unnuga:

- hub in qaadidaw, ama hub ki haysidii, iskoolka, goobta iskoolka, ama iskoolka howlooga soo abaabulo;
- og ii haaysido daroogo sharcidaro eh, am iibiyaw ama isti'maalaw wal iskoolka liki kontorooli ama hoola iskoolka; AMA
- "sababi dhaawac kor oo doron oo qof kale in jeeysidi inta iskoolka, meelooga iskoolka, ama iskoolka howlooga soo abaabulo la roogo."

Way intaas dheertaa, Sarkaalka Dhugunsiga way suurto gal ataa in ardayga ki qoro, sababto ato ardayga oo qatar eed in wiin naftiis/naftiyee ama ardayda kale oo isla dhigidaayan ki ayo, **ee IAES iskala jiraan ilaa 45 maalin maalmood** iyidoo la qobodaw dhugunsi nidaam jira oo deg-deg ayo.

IAES ta way waa unnuga awood in siyaan in sii wedeto iskoolkshey ee manhajka guud ii hadafyadiis ee unnuga IEP shey, inkastoo meel kale ayo. Adeegyo liinka tala gali in ku horseeto aqlaaqda in soo nagato ayaa sidoo kale la biyee.

Inta liki jiro Meeleenta unnuga ee IAES, Koohda IEP way waa in (haddii qof sidaas hore aniin suubine) in qobodo FBA oo la soo saaro qorshe dhehgal dhaqan oo mid hubaal ayo. Shir go'aan muuqda ayaa sidoo kale la qobode doone. Mududii ardayga ki jiro IAES ayaa Koohda IEP way taas in ogolaadaase in:

- ardayga ku saaraan meela hada dhigidooyo;
- ku fiirsidaan IEP hadda ki jiro in ayo meela inka haboon oo isbedel soo jeediyaan, haddii ki haboonto; ii
- ku fiirsidaan inka haboon yo meela ki jiro oo dhacdada ku dhiisi oo isbedel soo jeediyaan, haddii ki haboonto.

Daroogo mamnuuca micinaashe way waa shay li higmooyi, laakiin mi ki jiro shay si sharci ahaan liin haysido ama lin isticmaalaw hoos kooyaaaw Heerka ama qodob kale oo sharci Federaal eh.

Hub way lisiyeey harafka "hubka qatarta" oo ki hoos yaalo jumlada (2) ee Qeeb hoosaadka koowaad (g) ee Qeebta 94\30 ee cutubka 18, USC.

Dhaawac Jir Aad in Doron way leyaa micnaha la siyi harafkaas oo ki hoos yaalo jumlada (3) ee Qeeb hoosaadka (h) ee Qeebta 1365 ee cutubka 18, USC.

Huguuqda Raf'aan Ku Qaadashada Adi ama iskoolka degmada way suurto gal ataa in raf'aan ku qaaditaan go'aanka la hiriira go'aan muuqdo ama leeyenta meela walbarasho ku meel gaarka adi oo ku dalbadaaso dhugunsiga nidaam jira. Adi ama iskoolka degmada way suurto gal ataa in dalbataan “dhugunsi deg-deg” ato si liin haliyo arrimooga sida inka dhaqo badan oo suurto galka ayo.

Dhugunsiga Nidaam jiro Deg-degga ee Arrimooga Aqlaaqda la Hiriira Marka arrimooga aqlaaqda lug ki leto

deg-degga (dhoqso) dhugunsiga nidaam jira:

- way waa inii qobodaa sarkaalka dhugunsiga nidaam jiro kasoo soo buuyi shuruudooga in qobodo Sarkaalka Dhugunsiga ee Waahda Walbarashada ee Gobolka;
- way waa in luku qobodaa 20 maalin ee maalmooga iskoolka, oo go'aanna luku deeraa 10 maalin ee maalmooga iskoolka gudusho;
- raf'aan ayaa luku qaadidi kore, sida go'aan dhugunsi nidaam jiro oo dhon, sida in tilmaameen Waahda Walbarashada Ee Gobolka NH. Intii so'odo hanaanka raf'aan qaadashada, unnuga way la fadheesiyeeye oo liki sii haayee IAES, ilaa Sarkaalka Dhugunsiga go'aanshey/go'aanshe ku deeraaso ama ilaa ii 45-maalin ee maalooga iskoolka ku hor inta in dhamaane. Haddii iskoolka degmada oo weli dareensiyo in unugaa cabsi ka ayo amaanka kuwa kale, way suurto gal ataa inaa odsidaan in unnuga liki haayo meela “ki meelgaarka” eh, ama in usi/iyi la fadheesiyo meel kale wal kibaradaan oo Koohda IEP soo jeediyeen. Unnuga way ki nagadeyee meeli usi/iye hor inki jirijirtii inta dhugunsiga so codo ilaa iskoolka degmada aaminsinto in unnuga ki nagashashaddiis qatar geliyaaso amaanka cunug ama kuwa kale. Marka sidaas ato, iskoolka degmada way suurto gal ataa in dalbado in dhugunsiga dacwada la soo de dejhiyo. Way dhiyi kortaa in hanaankan laka soo nago sida liinka baahido. Heshiis la'aanta ki saabsan in cunug itaal doron in liin wareejiyo IAES ama meel kale Sarkaalka Dhugunsiga in dooro, Sarkaalka Dhugunsiga way waa in oo rahaa walaagii liin ki baahinaayi usi/iye oo isticmaali fadii markii Meeleenta ki suubiyaw ee IAES.

Haddii iskoolka degmada edbiyo cunug qabo itaal doronaan, hanaanka quseeyo dhamaan ilmooga oo dhan, ku bacdi iskoolka degmada way waa in diraa diiwaan gelinta walbarashada gaarka eh ii diiwangelinta aqlaaqda oo in diraa shaqsiga ama shaqsiyaadka go'aanka kama dambooska iska leyaan oo ki saabsan tilaabooyinka edbinta.

Ardayda Go'aan Al Ku Deerne In Haq In Levaan Walbarashada Gaarka Eh Ardayda weli al ogaane, laakin ki socoto tillaabo edbin, ilaalista qeebtan ki qeehan way kaliya quseeyaa haddii iskoolka degmada agaansho in layo in unnuga ayo cunug itaal doron qabo may weeli:

- waalidka wel-wel ayaa muujiyi, qoraal ahaan, in diri shaqaalaha iskoolka in cunugsho in baahinyo walbarasho gaar eh ii adeegdheeda la hiriira;
- waalidka dhali unnuga odsidi in cunugshey qiimeen liki suubiyi;
- macalin (ama shaqaalaha iskoolka degmada ee kale) muujiyeen wel-wel ki saabsan tilmaamo edeb ama wal qobod in sheegeen agaasimaha walbarashada gaarka eh ama shaqaalaha horroogiyaasha sida qabo iskoolka degmada (Child Find) ama nidaamka in gudbinta.

Qiimeen Inta Socoto Hanaanka Edbinta Haddii adi qiimeenta in conditi unnuga inta socoto hanaanka edbinta, qiimeenta way waa in la qobodaa sida inka dhaqsiyaha badan (deg-degga), OO unugaaga way laka haaye meela walbarashada oo go'aamiyaan mas'uuliyiinta walbarashada ee mudida iskoolka luku soo roojiyaayi ee hore, kasoo ki mid nagado koro buris ama roojis lyigoo adeegyo walbarasho alsiyaayne. Haddii liin ogaado in unugaa ayo cunug itaal doron, iskoolka degmada way waa in siyaa walbarasho gaar ii adeegyo la hiriira, oo la so'odo muddadii raf'aanka ii/ama meeleenta meel bedel walbarashom kumeelgaadha (IAES) socoto.

In gudbin ii Tillaabo ka gaadayaan Booliiska ii Mas'uuliyiinta Shar'iga IDEA 2004 hay'ad ma ka mamnuucaaso in warbihin ku gudbiso haddii dembi usi galo cunug qabo itaal doro in gudbiso mas'uuliyiinta ki haboon ama booliiska gobolka ii mas'uuliyiinta shar'iga kku ku reebto in waajibaadsho ku soo bahaan arrimooga quseeyo shar'iga Gobolka ii shar'iga Federaalka.

Shar'iga gobolka way ki soo rogi koree hadi waqti qaarsheey, kasoo liinka weeraw “koobnaanta woqtiga haqa,” ee tillaaboyinka la hiriira dhugunsiga nidaam jiro, raf'aanyaalka mahkamada gobolka ii mahkamada federaalka, ii soo nogawka qarashka abukaatiga ii noo nagowka qarashka walbarashada liin biyo ee meeleenta aliska qabne.

Haddii waalidka ama iskoorka degmada ki guul daroysido in ku soo baho woqtiga hadidan, way waa in dhumiyaan huquuqdiyoo ki dalbadi fadeen dhugunsiga dacwada nidaam jiro ama racfaan ku qaadidaan go'aanka Sarkaalka Dhugunsiga ee mahkamada.

Kuwa soo so'odo way waa qoraal koobun ee muhiimada woqtiga hadidan:

- waalidka waa in odsidaa dhugunsiga nidaam jiro 2 sano gudushoo luku bilaabo taariikta gefka la jeysida oo la ogaadi ama sida la sheegaw la ogaadi;
- waalidka waa in odsidaa dhugunsiga nidaam jiro 90 maalin gudushoo si liin halo qarashka meeleenta aliska qabne;

May in haloytee wargelintan qoron si lakiin siiyo ma'luumaad ki saabsan huquuqda ii ilaalinta haggaa shar'iga walbarashada gaarka eh ee federaalka, heerka walbarashada shaqsiyaadka itaalka doron (IDEA), oo ki saabsan isti'maalka ama beesada gargaarka dadwiinaga ama aymiska ee ilmogaa leya. New Hampshire gudaheeda "beesada gargaarka dadwiinaga ama aymiska" may waa Medicaid, taasoo soo maraaso Medicaid-ka Gobolka iyeena biyaasi mayna ku biyaasee barnaamijka iskooleda oo iniski jiraan barnaamijyada Medicaid iidoo in marsiyaaso ururoo daryeelka in maareysan. Iidoo barnaamijka Iskooleda lin soo marsiiyaw Medicaid, iskoolada degmayaasha NH ee gobolka dhon may helaayaanaa sanadkiiba malaayiin doolar eh oo si kale ki soo galeen ilaha Gobolka ama maalgelintadeegaanka.

IDEA may maalgelin ku biyaase qeeb ku mid ah walbarashada gaar eh ee ilmoogaa ii addeegyada kaleet oo li hiriir. Barnaamijka maalgelinada manfa'yada dadwiinaga ama aymiska, taas oo NH Medicaid ku eta, sidoo kaleet may lin is ti'maala koree iskoolada degmada si in kaalmooyto biyowka walbarashada gaarka eh ii ageegyada li hiriir oo ki saleysan IEP ee iloogaa in baahanyiin, illeyse may ku hirantaa inii biito oggolaanshagaa. Iskoolka degmadaa maku hala korto dheefta Medicaid ee ilmoogaaleyin hoo sababto inii beeso lakiin soo raa'ado, ama ii beeso ki weelato dheeftaa aawadiye ama siyaado ki koyto aymiskaa.

Iskoolka degmada iye masuul ku eh in hubiyo inii ilmoogaa helaan addeeg yada oo dhon ee IEP- usu leya, iidoo lin fiiriyaane inii biido oggolaansho iskoolka degmada inii isti'maalaan dheefta ilmoogaa ee gargaarka dadwiinaga ama aymiska. Hoo adda oggolaansho in biine, ama kulu bato oggolaanshagaa kudambe maddii ada oggolaansho biiti, saameyn muku weeladaaso dhammaan addeegyada ilmooga in halaayaan IEP haan meeliyee iye ku dareeraayaan. May sidoo kale adad lakinka baahanyaa inii odsato ama iski diiwaangeliido Medicaid-ka ilmooga si an halaan addeegyada walbarashada gaarka eh.

AMEE WARGELIN QORON WAAJIB ETA INI LI BIYO

Kohor intii iskoolka degmada yaalo ku warsane inii dhiibto oggolaansho adi ku halaaso Medicaid ilmoogaa maddii inki horroyto, maywaa inii ii ki siiyaan wargelintan oo ku mid eh huquuqda ii ilaainta adi hala karto oo hoos kooyaaso IDEA.

- IDEA may in baahantaa inii ada laka siiyo wargelintan kohor intii iskoolka degmadaa ku warsane inii isti'maalan Medicaid-ka ilmooga maddii inki horoyti,
- Kohor intii oggolaanshagaa halne inii isti'maalaan dheeftaas maddii inki horroyti; ii
- Tii sanadka intas kudambe.

Wargelintan qoron may waajib etaa inii luku qoro, luuqad la fahamo koro dadwiinaga guud ahaan ii afkiikaa ama noo' kale oo la iskula waramaw oo ada isti'maalasoo, anki haayne wal ma'quul oo li suubiyi korne.

OGGOLAANSHO WAALID

Kuhor intii iskoolka degmadaa isti'maala koro gargaarka dadwiinaga ama aymiskaa ama kii ilmoogaa maddii inki horroyti biyaaso si an halo walbarasho gaar eh ii addeega li hiriir oo hoos kooyaw IDEA, may waajib ku etaa inii halaan siihihaa oo taariikheysan ii oggolaansho qoron. Iskoolka degmadaa may ki siiyo doonee foomka oggolaanshaha si ada in siihiido oo in taariikheyso. Iskoolka degmada *halmar* keliya iye in baahnye inii halo.

Oggolaanshaha walaaga linki baahanya iye may shala eyaa lama qeybood:

1.) Oggolaanshaha sheegowka ma'luumaadka shaqsiga luku kasa koro ee ilmoogaa hay'ada gobolka masuul iye ku eta maarinta Medicaid.

- Si in halo Medicaid-ka ilmoogaa, qaar ma'luumaadka aqoonsi ku mid eh ee shaqsiydeed iye lin sheegi doone hay'ada Medicaid-ka gobolka ama wakiilka biilka Medicaid ujeedooyin biilka iskoolka degmada la hiriiro. Sida shar'iga federaalka ki ad, ogolaanshagaa oo qoraal eh iye lin baahanya kuhor intii iskoolka degmada siideyn Koran ma'luumaadka shaqsiga luku kasa koro (sida magaaga ilmooga, cinwaanka, lambarka ardayga, IEP-ga, ama natiijooyinka qiimeenta) ee diiwaanka walbarashada ilmoogaa ee dhini kaleet oo an haayne iskoolka degmadaa, maddii luku reebo qaar u mid eh. Ogolaanshagaa kowaad may in ogolaadeeyee iskoolka degmadaa inii sheegaan ma'luumaadka shaqsiga luku kasa koro mayweeley may in isti'maalayaan inii Medicaid siyan beesada Medicaid, hay'ada Gobolka ama wakiilka biilka Medicaid.

2.) Warka qoraalka eh I halaayaan oo ki saabsan Medicaid-ka ilmoogaa:

- Ogolaanshagaa in ogolaadaaso iskoolka degmadaa inii isti'maalaan Medicaid ilmoogaa ma kiinka kohow wal qarash eh, wal saameyn ehna muku weeladaw hadhow dambe oo ki saabsan aafimaad daruuri eh ilmooga ma hala kore ii doo toos lin maraw nidaama Medicaid. May jiraa ilaalo qeexan oo ku saabsan isti'maalka Medicaid:
 - Iskoolka degmada may waajib ki etaa inii sheeno oggolaanshaga waalidka kuhor intii lin isti'maalne Medicaid-ka ilmoogaa maddii inki horreyti.
 - Iskoolka degmadaa ma hala koro mana (isti'maala) koro Medicaid-ka ilmoogaa hoo taas in isti'maala lahaayi:
 - Inii yaraayo aymiska umriga ee la hala koro ama dheef kale oo Medicaid biyaaso;
 - Inii sababo inii qaraabada biyaan adeegyada aafimaadka la hiriiro (hoo ahaada fadiwal iskoolka luku biyaw ii wal kaleetba) oo Medicaid-ka ilmoogaa biyo fadeen.
 - Inii kii siyaadiyaan aymiska (hoo suurogal nagato) ama in horseedaan inii lokoo roojihiyo manaafacaadka ama aymiska hala fadi; ama
 - Qatargeliyaan inii koo lumo haq I weelashada guri ii tanaasulaadka lin suubiyaad bulshada, oo ki saleysan qarashaadka aafimaadka badan oo kibahaw.

- Hoo adai fadaane inii iskoolka degmada sii wado biilka walbarashada gaarka eh ii adeegyada li hiriiro barnaamijka manaafa'aadka dadwiinaga ama aymiska ee walbarashada gaarka eh oo hoos koyaaw IDEA, may in baahada doontee inii kala noqoto oggolaanshagaa kaas oo in oggolaadaw iskoolka degmada ini halaan manfa'a ama aymiska ilmoogaa. Kala nagadawka oggolaanshagaa may ka bohoytee inii masuuliyiinkta iskoolka degmada halaan barnaamijka manfa'a dadwiinga Gobolka ama aymiska ee ilmoogaa leya. Kala nagadawgan oggolaanshaga may dhaqangaleeyee maddii iskoolka degmada halo kala nagadawkaa oo siihihan.
